Board Minutes October 20, 2015

The Board of Trustees met in regular session with Chairman Michael J. Wallner and Trustees Carl L. Heinrich, Martin L. Brooks, Maureen R. Kruse and Caitlin A. Beresford. Staff Present: CEO & General Manager Drummey, Administrative Manager Wisniski, Staff Engineer Cady, and Administrative Assistant Powell.

- I. The Chairman called the meeting to order at 4:30 p.m.

Shore Drive and discovered that the foundation was being built in an easement owned by the Council Bluffs Water Works. They are requesting that they would like to have 10 feet of the easement released and obtain an additional 10 feet of easement from their northern neighbor's property, so they can build a house per plan.

The Chairman requested the general manager to explain to the Board the reason why we need to retain the easement even though the water main has been out of service. The general manager explained to the Board that even though the main has been out of service over the recent years, the Water Works owns an easement that also contains a City sanitary sewer main. It is unknown at this time, but the Council Bluffs Water Works may need to use this easement in the future for a water main. Currently, the City is planning to reconstruct the streets and sewer in this part of town.

The Board asked if the easement and release would be recorded. The general manager responded, yes. The Board asked the general manager if he agreed with the releasing of the easement, he responded, yes.

The Chairman asked if there were any further questions or comments. Receiving no response the Chairman closed the public hearing.
